Thank you. Only thing we were missing was motive. Now you've kindly provided that.

## BRENT

No, look -- I was drunk, and pissed. But the minute I woke up I regretted leaving that message. That's why I bailed on the outing this morning. I was too embarrassed to face Dauls.
